## Product Discontinuation Announcement for EMEA and AMS Region – Hirschmann GRS1020/1030 Product Family

Dear Valued Customer,

This letter serves as your formal notification that Belden is discontinuing **the Hirschmann GRS1020/1030 product family**, effective February 2<sup>nd</sup> 2026.

In order to meet the latest market and technology trends, Belden is constantly developing innovative and high-quality products and variants that complement and optimize our existing portfolio. Every product has a defined life cycle, and our products are typically characterized by a very long availability on the market. However, product discontinuation becomes inevitable over a period. Due to evolving cybersecurity requirements and the need to comply with the EU Cyber Resilience Act (CRA), significant software enhancements are required across multiple switch families. However, certain switch families are constrained by hardware limitations and are therefore unable to support the necessary software changes to meet these security requirements. As a result, we are discontinuing these product families and offering alternative solutions that deliver similar or enhanced functionality while fully complying with CRA requirements.

The standard warranty terms apply to all products delivered up to the last delivery date.
