This letter serves as your formal notification that Belden will discontinue the **MICE product family**, which is part of **Hirschmann's Classic Software platform**.

Hirschmann's Classic Software Switches were launched between 2005 and 2010 and played a groundbreaking role in the adoption of Ethernet in industrial environments. In line with our commitment to our product longevity, and our customers' requirement for continuity, we are still manufacturing the same products today.

Due to changes in the semi-conductor industry, procurement of chips based on older process node technologies is no longer possible, and this directly affects our capability to manufacture the MICE switches.

The <u>MSP Family</u> is part of Hirschmann's latest hardware generation. This product family is a tried and trusted product line and run the state-of-the-art Hirschmann Operating System HiOS. Our product families running HiOS software are drop-in replacements for their Classic Software based equivalents. This allows a gradual and planned migration to the latest technology, with no unscheduled downtime.
